Executive Summary:

The meeting focused on operational updates, public safety, infrastructure improvements, and ongoing development in the Fort Worth Stockyards District. Key topics included police beat realignment, crime statistics and trends, security enhancements (notably additional Flock cameras), noise and traffic concerns, pedestrian safety, signage and wayfinding projects, maintenance initiatives, and updates on district development and leadership. The group discussed collaborative strategies to address underage activity, unauthorized vendors, parking and rideshare congestion, and the need for improved communication among security teams, streetlighting, sidewalk repairs, and coordination with city departments.

II. Financial Report

Paul Paine presented the PID11 FY 25/26 Budget Proposal with supporting details and the FY24/25 Mid-Year Tracking Report with actual expenditures to budget through June 30th.

III. Police Reports

Officer Moncada presented the police's quarterly crime statics reports for the Stockyards during 04/01/25 - 07/23/25 and discussed the areas where crimes were reported, the breakdown of types of offenses, and the number of offenses.

IV. New Business

Paul Paine provided an update on the following ongoing PID projects:

- E. Exchange Ave tree pruning and fertilizing.
- Safety hazard concerns being addressed by replacing missing wood in various W Exchange Ave sidewalk expansion gaps.

Paul Paine presented the following Proposed PID Projects:

- Request for Rodeo Plaza planter boxes to have the ground cover replaced with decomposed granite to improve the aesthetics and reduce maintenance.

Pam Minick made a motion to approve funding this proposal as presented. Philip Murrin seconded the motion. Motion passed.

- Request for a kiosk sign at the NE corner of E Exchange & Rodeo Plaza to direct foot traffic to the Rodeo Plaza Museums, Restaurants, Businesses, and Billy Bob's.
- Clean up of debris along Marine Creek Saunders Park Area.

The proposals for the Kiosk signage and clean-up of debris along Marine Creek were supported as good ideas to continue working on and to bring back invoices for the PID Board to consider.
